1. INTRODUCTION

This classification report defines the classification assigned to **Avery Dennison® MPI 1440 Ultra Transparent** in accordance with the procedures given in EN 13501-1:2018.

2. DETAILS OF CLASSIFIED PRODUCT

2.1 GENERAL

The product, **Avery Dennison® MPI 1440 Ultra Transparent**, is defined as a multi-purpose vinyl.

2.3 PRODUCT DESCRIPTION

According to the sponsor the product is composed of:

- Face film: 40 micron gloss transparent cast vinyl with a mass per unit area of approx. 8.6 g/m²;
- Adhesive: 30 µm Permanent, clear, acrylic based;
- Backing paper: 70 µm Clear PET with a mass per unit area of approx. 72 g/m².

The product has a total thickness of approx. 70 µm, the product has a mass per unit area of approx. 16 g/m² (measured on the product).
